## Terms and Conditions

"Okeko Facilitator" means the individual, person who introduces the concept of Okeko and signals the beginning and end of an Okeko Gathering and/or the individual, person providing for Okeko Services and Facilitation in an Okeko Gathering and/or session.

"Okeko Participant" means the individual, person who participates in an Okeko Gathering, session and/or Okeko Services and Facilitation, the visitor, guest, observer in an Okeko Gathering, session and/or Okeko Services and Facilitation and/or the user, consumer of Okeko Services and Facilitation.

All sites and references to all sites includes the Content which is made up and includes:

At all Okeko Gatherings, Sessions and/or Okeko Services and Facilitation, photography, audio and video recording may occur. Footage, audio and images captured will be used for educational and promotional purposes and may appear in print, on all sites, external sites and on social media. Please let the Okeko Organiser and Facilitator know if you do not wish to be captured on photographs or on film.

Okeko Gatherings are not suitable for infants and toddlers (age 0-2). Booking for Okeko Services and Facilitation requires that you are at least 18 years old. Only legal representatives (parent/guardian/caregiver) can book for minors (age 3-17) communication impaired adults and/or domestic animals.

In the 'questionnaire' of the [ticketsource.co.uk](http://ticketsource.co.uk) booking website you can request additional sessions (on top of your own booking) for minors, communication impaired adults and/or domestic animals which will be confirmed by us, depending on the availability of tickets at the moment of your booking, by email, using the email address provided by you in the booking.

Note that additional bookings are only allowed for minors, communication impaired adults and/or domestic animals, everyone else must book for their own session (one ticket per person).

The legal representative responsible for minors, communication impaired adults and/or domestic animals always attends for the whole duration of Okeko Gatherings and/or sessions as an Okeko Participant in Okeko Services and Facilitation.

The Contract will relate only to those Okeko Services and Facilitation which we have confirmed in the Accept Confirmation. We will not be obliged to supply any other Services and Facilitation which may have been part of your message and/or invitation until these Services and Facilitation have been confirmed in a separate Accept Confirmation.

Some Okeko Services and Facilitation are available by booking tickets through the use of External Sites and Third Party websites, such as [TicketSource.co.uk](http://TicketSource.co.uk); by booking for Okeko Services and Facilitation, you confirm that you understand, accept and agree to Okeko's Terms and Conditions and understand, accept, agree and consent to the '[OKEKO GATHERING CONSENT FORM](#)'. You will be responsible for all communications, payments and contracts with these External Sites and Third Parties.

After booking for Okeko Services and Facilitation you will receive an 'Order Confirmation' that will take the form of a summary web page at the end of the booking sequence. This will be followed by an email dispatched to you (depending on your email program spam settings, the email may end up in your

junk or spam folder so please check these folders.) Both the summary web page and email order confirmation contain details of the booking with a unique reference number, which acts as your proof of booking and payment which may be used as an e-ticket.

If you book for Okeko Services and Facilitation by telephone, using the TicketSource telephone service or if you are not able to print your email order confirmation to be used as e-ticket, your unique booking reference number and proof of ID will grant entrance to the Okeko Gathering and/or session. Note that in situations where the refund policy is applicable, the telephone service fee (£ 1.75) is not refundable.

If you do not receive a confirmation number (in the form of a confirmation web page or email) after submitting your booking information, it is your responsibility to confirm with the Customer Service Department of TicketSource.co.uk whether the order has been completed, as only you may be aware of any problems that may occur during the booking process. TicketSource.co.uk will not be responsible for losses (monetary or otherwise) if you assume that an order was placed but failed to receive confirmation.

If you have booked and paid for Okeko Services and Facilitation directly to us or by using External Sites and/or Third Party websites, there are no refunds possible for the fees, prices and/or costs paid in accordance with our refunds policy as these are all-inclusive packages including travel, venue and booking expenses. At our discretion and decision, upon examining individual cases it might be possible to resell your booking to someone else and reschedule an appointment for you free of charge.

In the unlikely event and in case we have to cancel Okeko Services and Facilitation that you have booked and paid for through the Third Party Website TicketSource.co.uk, there will be a £1 (one pound) refund fee, that is charged by TicketSource.co.uk which will be deducted from the total booking price that you will receive as a refund in the same way and on the same account that was used to book and pay for your ticket. You will be responsible for all communications, payments, refunds and contracts with TicketSource.co.uk.

We will not be liable in any amount for failure to perform any obligation connected to Okeko Services and Facilitation under this agreement if such failure is caused by the occurrence of any unforeseen contingency beyond the reasonable control of such party including Internet, telephone and public transport services interruptions, fire, flood, storm, snow or other (weather) conditions, conflict, war or act of God that hinder (travel to provide for) Okeko Services and Facilitation.

If you arrive late on the booked appointment, the full session price will be charged for the remaining session time. At our discretion and decision, upon examining individual cases, it might be possible to resell your booking to someone else and reschedule without costs an appointment for you.

If you are contacting us as an organiser ("Okeko Organiser"), you may cancel a Contract at any time within 7 (seven) days, beginning on the time after you received the Accept Confirmation. In this case, you will only receive a full refund of the price paid for the Travel and/or Accommodation costs of the Okeko Facilitator ("Okeko Facilitator") in accordance with our refunds policy, if the Okeko Facilitator is able to cancel without costs the Travel and/or Accommodation tickets and reservations from Third parties like Travel and/or Accommodation services (buses, airfares, hotels and so on).

To cancel a Contract, you must inform us in writing.



Your request and/or invitation will be fulfilled by the date set out in the Accept Confirmation unless there are exceptional circumstances. There will be no refund of costs made by the Okeko Organiser in case the Okeko Facilitator is not able to fulfil a request and/or invitation due to exceptional circumstances.

THE ORGANISATION OF AN OKEKO GATHERING, THE SUPPLY OF OKEKO SERVICES AND, FACILITATION, THE COLLECTION AND SAFEKEEPING OF SIGNATURES OF THE 'OKEKO GATHERING CONSENT FORM' BY ALL OKEKO PARTICIPANTS PRIOR TO AN OKEKO GATHERING AND FEEDBACK FROM OKEKO PARTICIPANTS WILL BE YOUR (OKEKO ORGANISER) RESPONSIBILITY FROM THE TIME OF THE ACCEPT CONFIRMATION.

Your (Okeko Organiser) request to and/or invitation of the Okeko Facilitator in the Okeko Gathering will only be fulfilled when we have received full payment of all sums due in respect of the Okeko Services and Facilitation.

Travel and/or Accommodation costs include VAT.

It is always possible that, despite our best efforts, Travel and/or Accommodation costs listed on our Accept Confirmation may be incorrectly priced. We will normally verify prices as part of our Accept Confirmation procedures so that, where Travel and/or Accommodation costs are correct priced is less than our stated price, we will charge the lower amount when fulfilling the request and/or invitation to you. If the Travel and/or Accommodation costs correct price is higher than the price stated on the Accept Confirmation, we will normally, at our discretion, provide proof of costs and either contact you for instructions before fulfilling the request and/or invitation, or reject your order and notify you that we are rejecting it. In this case there will be no refund of costs already paid to the Okeko Facilitator unless the Okeko Facilitator is able to cancel without costs the Travel and/or Accommodation tickets and reservations from Third parties like Travel and/or Accommodation services.

Payment for all Travel and/or Accommodation costs must be by bank transfer directly to us or directly to the Third parties who provide the Travel and/or Accommodation services as is specified in the agreement in the Accept Confirmation. If you, the Okeko Organiser pays directly to the Third parties who provide the Travel and/or Accommodation services, you will be responsible for all communications, payments and contracts with these Third parties. You must provide the tickets and/or reservations from these Third parties to the Okeko Facilitator before a request and/or invitation can be fulfilled.

If you cancel a Contract to us because:

- you have cancelled the Contract between us within the seven-day cooling-off period we will process the Travel and/or Accommodation refund due to you as soon as possible and, in any case, within 30 days of the day on which you gave us notice of cancellation. In this case, we will only refund the price of the Travel and/or Accommodation costs in full if the Okeko Facilitator is able to cancel tickets and reservations from Third parties like Travel and/or Accommodation services (buses, airfares, hotels and so on) and has received refunds of the costs made by the Okeko Facilitator. However, you will be responsible for the costs already made for tickets and reservations from Third parties that cannot be refunded by the Third parties Travel and/or Accommodation services.
